- 27. To arrange a visit I know that I ring the department; either that or I ask my carer to email my CSO. But I didn't ask my CSO about this visit to Dad because I know they would say no because of his past.
- 28. But I always, I always kept in contact with carers by phone. When I was at Dad's before I went to sleep I texted the carer and I was like, "I am still alive" smiley face. I got a text back and I just had to send the details like my dad's phone number.
- 29. They might say it is the wrong thing to do, but everyone knows by now that if I really need to see my dad I am going to go anyway.
- 30. My carers have taught me a lot of techniques to deal with people like dad and people who might be in his house independently. I love these carers. They are like family, basically. I have never seen a carer that has been lazy.
- 31. The carers have always given me enough clothes and food, and I can talk about personal issues with my carer. I love her: fair, strict but fair. She knows what she is doing.
- When I am catching the train to the sometimes I see my mum around with my sister. I don't meet up with her, she is just there; I just bump into her.
- 33. I go to and I am going into grade ten this year. I enjoy school and I go every day. English and Food Studies are my favourite subjects. I like seeing my friends at school, but I think I should concentrate on my education more.
- 34. I have only told close friends at school that I am living with I let I them about this house and they go "Oh I wish I was living there." I feel good that I have the opportunities that come from living at this house, but I don't talk about it much.
- 35. I don't really like going over to friend's houses, and you are not allowed to bring friends over here to the house.
- 36. I get a lift to school but I catch the bus home from school. I have a *go* card and the carers put money on it every couple of weeks.

- 37. Homework has been easy in every residential house that I have been to before, because you can just go up to carers and ask them to help you and they do.
- 38. My room is a good, quiet place where I can do my homework. I do my homework on my bed; I don't have a desk yet, and I don't want one.
- 39. Three years ago a foster carer gave me a Compaq laptop, which I use to complete assignments. We don't have Wi-Fi yet but I can just turn my hot spot on, on my phone, to access the internet.
- 40. I have never been offered drugs at they used to at but not here. This is because I don't hang around that crew anymore.
- 41. I have seen people using drugs in residential care. If they did it in front of me I would always tell the carers because I don't want that in the house. Yes, yuck, I don't want to do drugs.
- 42. Kids do drink alcohol but not at the house. If they were to drink they would go to their friend's house and stay there the night. But I am not like that.
- 43. When I leave school, I want to be a veterinarian or a policewoman. I want to be a policewoman because you are not doing the same stuff every day. I have spoken to some police officers about becoming a policewoman and they were very encouraging.
- 44. I have also thought about joining the Air Force. I love cooking too and could train to be a professional chef; I can do courses at school in year eleven and twelve, like my hospitality course.
- 45. If I could change the way that care works, one thing I would change is how often Child Safety Officers visit. Yes, my contact with my CSO. I have had my CSO since October last year and he has not come and visited me once. Every month your CSO has to come and visit you.
- 46. My last CSO was really good, she was really on the ball and she would always come and see me every month. She would email Jodie straight back about some things. She would ring me if she wanted to talk to me.
- 47. Another problem is that when you try to get approval from the department the answer is always no. I sometimes feel powerless and that I am not involved in the choices that affect my life. I haven't had one phone call, one visit. The first time I met my current CSO was when my old CSO was with him.

- 49. I've had the same counsellor for about three years. I have built a very close relationship with her.
- 50. I would recommend that children's social workers stay with over longer periods of time, and that other young people should be able to get onto a social worker if they feel low. I would say talk to someone. I think everyone should have a right to a counsellor.
- I think it would be a good idea to link kids to DOCCSS using Facebook. I think 51. this would connect with kids a lot better than by spending millions of dollars on resources.
- 52. I have also opened up to the carers too so I have worked. But that is only if I trust them and I know that they are alright. It takes a lot for me to trust someone.
