(d) explaining the basis on which it is said the applicant's interests are sufficiently connected with or likely to be materially affected by the work of the Commission bearing in mind the Terms of Reference published on the Commission's website; and

Ms Jackson is of the Gurang Gurang clan. Both her parents were Aboriginal, with her father from the Stolen Generation. Ms Jackson has had extensive experience with the child protection system through many roles: as a grandmother; a mother; a kinship carer; and member of her clan; as well as involvement with IFACSS and the systemic child protection process such as family meetings and Cultural Plans.


