STATEMENT OF BRUCE MARSHALL

I, BRUCE MARSHALL, of c/- 205B Bowenda Drive Aurukun in the State of Queensland, Service Development and Integration Officer, solemnly and sincerely affirm and declare:

- I am a Service Development and Integration Officer in Community Services Funding and Support (previously Community Capacity and Service Quality), Department of Communities, Child Safety and Disability Services.
- I have been appointed to this AO6 level position since August 2010. I live and work in the Aurukun Community.
- When planning and reviewing my work and seeking approval for decisions, when required, I reported to Mr Paul Millard, Principal Service Officer, who is based in Cairns. My position is part of Community Services Funding and Support of which Ms Tracey Harding is Manager. Ms Tracey Harding is based in Cairns and reports to Mr Desmond Lee, Far North Queensland Regional Director Disability and Community Services, Department of Communities, Child Safety and Disability Services.
- 4. Prior to this appointment I was employed in the following positions:
 - June 2007 to August 2010 I was the Owner/Operator of AMRO Training and Consulting. I designed and delivered mentoring programs within the Welfare Reform Communities of Aurukun, Coen, Hopevale and Mossman Gorge. This program was funded by Department of Education, Employment and Workplace Relations
 - May 2003 to May 2007 I was the Chief Executive Officer for Maningrida Jobs Education and Training Aboriginal Corporation in the Northern Territory
 - For ten years I worked and lived in remote communities in Western Australia and managed large cattle stations.
- 5. I hold the following qualifications:
 - Certificate IV in Workplace Training and Assessment
 - Certificate IV in Occupational Health and Safety
 - Coxswain Certification
 - Commercial Pilot Licence.

ROLE

- 6. The purpose of my role, as the Service Development and Integration Officer based in the Aurukun Community, is to support the Aurukun community in reducing alcohol related harms by:
 - supporting funded services through capacity building and service improvement This
 may include: governance; policies and procedures; effective and appropriate
 processes; and, service and program development
 - assisting services provided in the community to work as part of an integrated service system.
- 7. This position is temporary. It is funded through the Alcohol Management Reform initiative to 31 December 2012.

 - working with individual services to address identified issues or capacity gaps
 - assisting with service/program planning and development
 - assisting boards and management committees in developing governance capacity

 - assisting with interagency meetings and supporting working groups
 - working with a place-based approach to ensure relevant achievable solutions
 - assisting with organising and/or facilitating workshops.
- 9. As part of my role I have provided support to the:

 - · facilitation of applicable guest attendance i.e. parenting coordinator
 - provision of information regarding applicable referral opportunities
 - school programs including:
 - photography programs that helped young people to show their community through their own eyes.
- 10. In recent months I have also taken on some additional coordination and logistical support roles as the Department of Aboriginal and Torres Strait Islander and Multicultural Affairs no longer have a position based in Aurukun.

 - volunteer marine rescue training of community members resulting in increased capacity within the Aurukun community.
