I Trudy Notley state;

1. My full and correct name is Trudy Notley and I am 48 years of age having been born on the 21 February 1964. I am currently running a Child Care Centre Business with my husband. I am also formerly known as Trudy Lewis.
2. On the 12 September 2012, I was approached by Detective Sergeant Fabian Colless of the Office of the Child Protection Commission of Inquiry and provided the details contained within this statement.
3. I am a former employee of the John Oxley Youth Centre (JOYC) where I worked for just over 12 months in 1988 and 1989. I recall my principal duties at JOYC were to monitor the alarms. I remember that the Manager at the Centre at that time was Peter Coyne and the deputy manager was Anne Dutney who is my sister. After leaving JOYC I went overseas and when I returned I did not return to work at JOYC. I recall at that time I was a hairdresser and used to cut some of the child detainees hair.
4. I remember one of the child detainees at the time I was employed there was a girl by the name of [REDACTED]

5. I was not aware of any problems at JOYC while I was working there. I did not supply any statements or letters of complaints while at JOYC that I recall, nor did I supply any statements or letters of complaints to the union.
6. I was not aware of any inquiry conducted at JOYC nor did I give any evidence to any inquiry while employed at JOYC or when I left JOYC. I did not give any evidence, statements or submissions to the Ford inquiry or at any Parliamentary inquiries.
7. I did not give any evidence of sexual abuse to any of these inquiries nor did I give any evidence about the excursion mentioned above to any inquiry. I am not aware of any other incidents of sexual abuse at JOYC or any other centre other than sexual behaviour between other children.
8. On the 12 September 2012, I was shown a list of staff, by Detective Colless, who were employed at JOYC around the time of my employment. I was able to identify a number of staff on this list as being there when I was employed.
9. On the 12 September 2012, I was shown a photocopy of a hand written document dated 3rd October 1989 signed 'Very Concerned'. I am not the author of this document, nor am I able to recognise the handwriting on the document.
