## Fabian Colless states:

- I am a Detective Sergeant of Police, registered number 9632, currently 1. assigned to the Police team assisting the Queensland Child Protection Commission of Inquiry (QCPCI).
- 2. My duties with the Inquiry have focused on gathering information in relation to the original terms of reference 3(e) for consideration by the Commissioner in reviewing the adequacy and appropriateness of any response of, and action taken by, government to allegations, including any allegations of criminal conduct associated with government responses, into historic child sexual abuse in youth detention centres.
- 3. Upon commencement of these duties I conducted a review of information and documentation relating to the following matters.

- 4. In relation to term of reference 3(e) it was determined that a departmental investigation commonly known as the 'Heiner Inquiry' conducted at the John Oxley Youth Centre (JOYC) in 1989 by retired Magistrate Noel Oscar Heiner was possibly relevant to term of reference 3(e). I commenced to gather information in relation to this matter.
- 5. In relation to an incident commonly known as the 'Harding incident' (involving former child detainee Annette Harding) which occurred on the 24 May 1988 at the Lower Portals, Queensland it was determined that this matter was possibly relevant to term of reference 3(e). I commenced to gather information in relation to this matter.
- 6. In relation to an incident which occurred on the 4 April 1991 at the Wivenhoe Dam involving a then child domiciled at JOYC, it was determined that this matter was possibly relevant to the original terms of reference 3(e). I commenced to gather information in relation to this matter.
- 7. The QCPCI Police team sought and obtained a large number of documents from a number of government departments and some non government organisations which were considered relevant to the gathering of information to investigate all three nominated matters.

- 8. A large number of persons were subsequently identified as possibly having relevant information for the Commission and inquiries were conducted to identify each person's current address and contact details.
- 9. The Police team systematically interviewed and or obtained statements from over 200 persons. In some instances persons were interviewed but no statements were obtained. The majority of persons were shown relevant documents which form part of the exhibits at the Commission. A number of persons were later summoned to appear before the Commission at respective term of reference 3(e) hearings.
- 10. Police inquiries revealed that a number of persons were now deceased. These persons were confirmed as deceased through inquiries with the department of Birth Deaths and Marriages. The relevant deaths certificates were obtained confirming same. The deceased witnesses (date of death) are:

Mr Freemantle was asked about his knowledge of the Annette Harding incident and he stated that he has read the document (exhibit 248) and could offer no further information other than what is contained within this document.

- 17. A summons to produce documents was served on both the Department of Communities and the Department of Justice in an attempt to identify these potential JOYC employees. The response from the Department of Justice advised that they were unable to provide any information about these persons or only limited information which was insufficient to identify and locate these persons. It is possible that some of these identification particulars are not accurate and therefore some of these persons may not be former employees of JOYC.
- 18. A number of other persons were identified within the documents examined by the commission (as per paragraph 7) and determined to be unable to provide any further information relevant to term of reference 3(e). These persons were not contacted and not interviewed in relation to the relevant matters.
- 19. Police also conducted inquiries in relation to Noel Oscar Heiner to determine if there were any items that had been in his possession that may have assisted the Commission hearings. It was ascertained that both Noel Heiner and his wife were deceased. Police contacted the direct descendants of Noel Heiner, two sons and a daughter. Inquiries with these persons revealed no known existing documents of Noel Oscar Heiner relating to the 'Heiner Affair'.
